Tenants across Britain are horrified and fearful.

At Grenfell the landlord ignored residents' concerns and warnings for years. We are all determined to win justice for the living and for all those who have died. Those responsible from the very top, must be made accountable.

Other landlords are ignoring residents in the same way. Dodgy cladding, inadequate fire safety, and criminal cuts to fire and other services,

threaten our safety across Britain.

Schools, hospitals and offices are also threatened.

We need full fire safety specifications for every block or home.

Government needs to pay for the safety measures – not tenants or leaseholders. We need to organise, to make sure homes and public buildings are safe.

We will not tolerate Government or the Mayor of London, pushing for demolition. This must not be used to

force people out. Most blocks need money spending on repairs and improvements and fire safety .

Grenfell is the terrible consequence of bullying and of privatisation, outsourcing and cutting corners to make money. It has to stop now. Government must give back the money robbed from council housing over 30 years, and invest now in existing and new council homes, with secure tenancies and council rents.

Landlords must listen!

DEMAND ACTION ON FIRE SAFETY

- **Justice for Grenfell – safe secure rehousing for everyone affected**
- **Remove all combustibile cladding immediately**
- **A full fire safety review, including all specifications of works already done**
- **Full government funding to carry out**

- all fire safety recommendations now**
- **Suspend redevelopment works until we re-scrutinise plans and materials**
- **Re-instate independent fire safety inspection, with reports publicly available and enforced**

- **Reverse the privatisation of health and safety, building control and materials research**
- **We demand landlords are made to listen – enforce a residents' right to vote on any redevelopment plans.**
