Template Letter re UC

Dear [NAME OF YOUR] MP,

In the forthcoming Spring budget, I am urging you, your party and the constituency you represent to support the permanent maintenance of the £20 Universal Credit and Working tax credit uplift and extend it to legacy benefits. As the Joseph Rowntree Trust research indicates, the legacy benefits group are mainly disabled, sick and carers, and it is vital they do not continue to be excluded from this uplift. Even with the uplift many working and non-working benefit claimants are having to choose between food, fuel and rent, which is disgraceful at any time, not only during the pandemic. The JRF estimate that keeping the uplift for families on UC/WTC will cost around £6.4 billion (2021/22), and extending it to legacy benefits will cost a further £1.9 billion.
